Product Overview

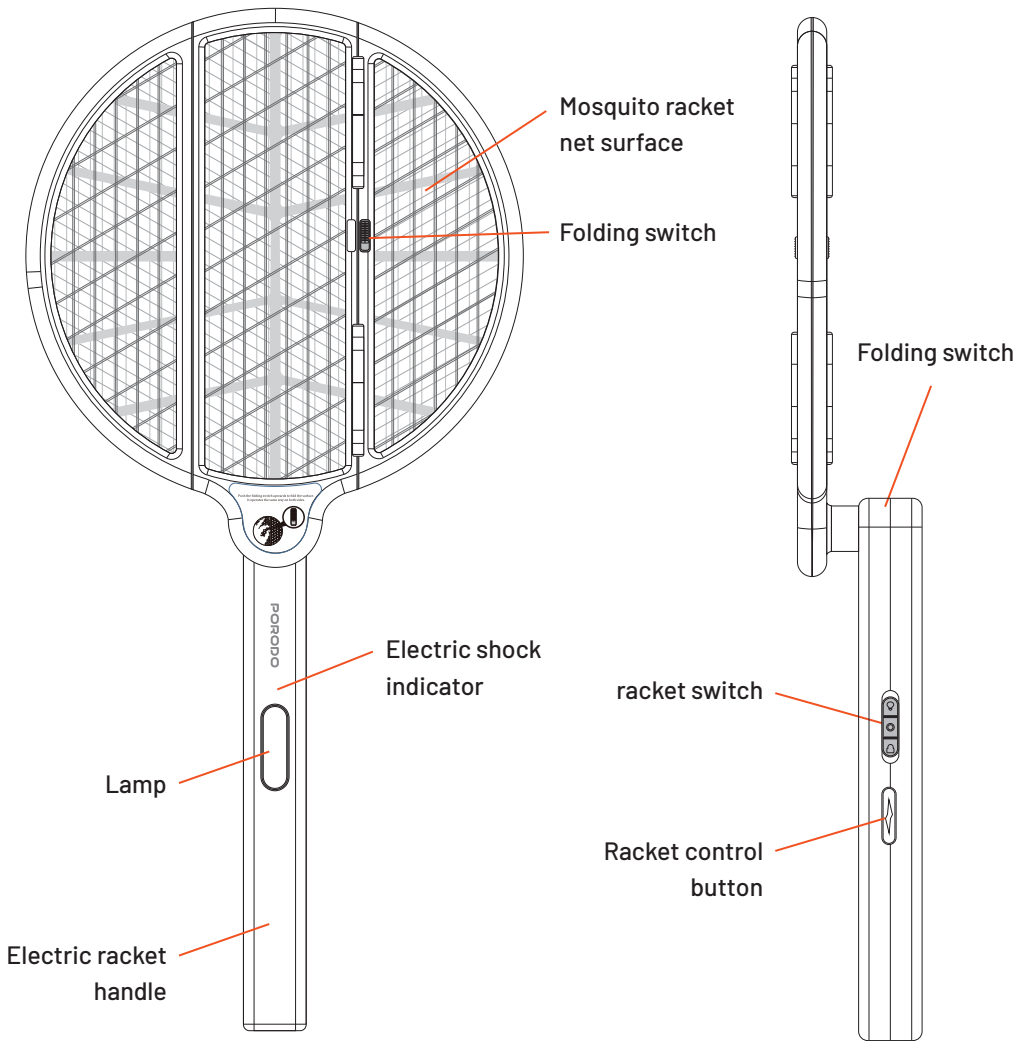
The Foldable Multifunctional Mosquito Killing Racket is a versatile and compact tool designed to eliminate mosquitoes effectively. With a powerful 2W output, it operates on a 1500mAh battery and supports an output voltage of 2800V. Made from durable ABS material, the racket is easy to fold and unfold, with a wide surface when expanded and a compact size when folded. It comes with a mosquito swatter, a cable for charging, and a user manual for easy operation.

Usage Instructions

1. Switch Off by Default

The device is turned off by default for safety before delivery. The mosquito control function is disabled. Ensure the switch is turned off when the device is not in use.

2. Activating the Electric Shock Control

- a. Push the switch up to the "standby" position.
- b. Press the mosquito control button () to activate the electric shock function.
- c. The electric shock indicator will light up, signaling high voltage on the metal net. Do not touch the metal net while it's active.
- d. Wave the device near mosquitoes to make contact.
- e. Release the mosquito control button to deactivate the shock function, causing the electric shock indicator to turn off.

3. Turning On the Grain Trap Light

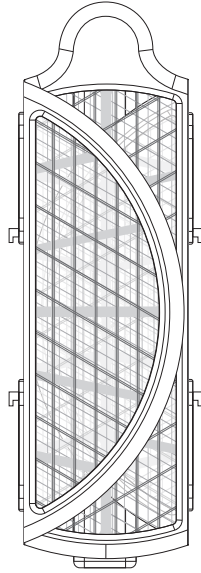
- a. Push the switch to the top to turn on the device.
- b. The grain trap light will illuminate, and the electric shock indicator will remain on.
- c. Caution: High voltage will be present on the metal wire. Do not touch the metal wire during this time.

Charging Instructions

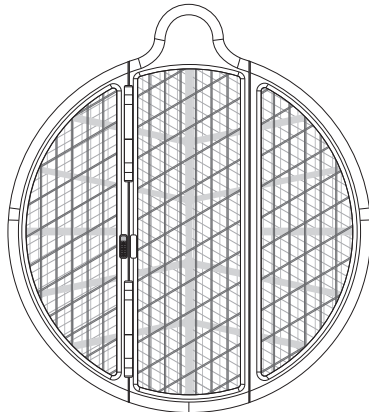
When charging, the charging indicator light is red, and when fully charged, the charging indicator light is green.

Usage scenarios

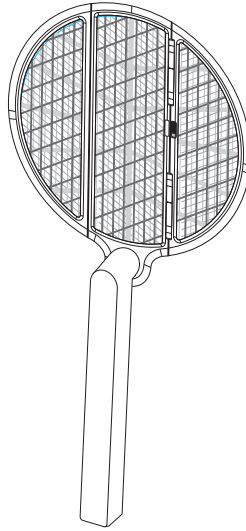
1. **Storage Mode:** The mosquito killing racket is folded and stored in its shutdown state.



2. **Active Use:** The mosquito trap is actively trapping and killing mosquitoes at night.



3. Electric Mode: The mosquito swatter is held in hand, operating in electric mosquito-zapping mode.



Safety Precautions

- 1. Electric Shock Risk:** High voltage may be generated on the metal mesh surface during use. Keep away from children, the elderly, and pets. Also, avoid storing in high temperatures to prevent electric shock.
- 2. Environment:** Not suitable for barns, livestock sheds, gas stations, or places with explosive dust or gases.
- 3. Avoid Sparks:** Do not use in areas with flammable or explosive gases, liquids, or dangerous chemicals. Keep away from metal objects like keys and spoons that could cause sparks.
- 4. Cleaning:** After use, turn off the device and clean the metal mesh with a small brush. Avoid using wet towels or paper towels, and do not wash with water to prevent short circuits.
- 5. Moisture:** Keep the device dry. In humid weather, the swatter may lose effectiveness due to moisture absorption. Dry with a hairdryer or place in the sun to avoid damage to internal components.

- 6. Battery Life:** If mosquito-killing effectiveness decreases, check the product's battery. Low voltage may impact performance and battery life. Recharge regularly.
- 7. Storage:** Avoid touching the metal mesh surface with hands or metal objects. When not in use, store in a dry, ventilated area to prevent moisture buildup.
- 8. Long-Term Storage:** If not used for extended periods, recharge the device every 2 months and store it in a dry location to avoid moisture.
- 9. Handling:** Do not use the racket to hit hard objects, as this can cause deformation and damage to the metal mesh surface. Always protect the mesh surface when not in use.

FCC Statement
